- Fine/Fee schedule CEO Whipple had previously submitted several fee schedules from other towns for review and discussion by the Town Board. There was some discussion but CEO Whipple was not present to answer questions. This will be brought up at the next meeting.
- Violations Malcolm asked for more details. Town Attorney Ed Brockman will be meeting with CEO Whipple to discuss further

HIGHWAY REPORT

- 154 MOTION TO APPROVE HIGHWAY REPORT NOVEMBER 2023 Malcolm made a motion to approve the November 2023 Highway Superintendent report; seconded by Dave. Ayes 4 (Ferry, Debra Cook, Craig, MacKenzie) Noes 0. Motion carried. RESIGNATION
- The Town has received a letter of resignation from James Pierce.
- Supervisor Craig started a discussion concerning increasing the starting salary of a new hire to the Highway crew to \$20/hour. He believes that the Town needs to increase the starting pay to attract new workers with Jay Pierce resigning and Eric Holtz planning to retire soon. Dave Ferry says that he sees companies advertising with a pay range based on experience. There was a lot of discussion as to how this would be received by the current employees and whether the union would support such a change. Malcolm is not opposed to negotiating with the union on this issue. He notes that it would be understood that this is a temporary change to the current union contract. Richard will speak with Eric Holtz about a meeting.
- 155 MOTION TO AUTHORIZE SUPERVISOR TO SET UP A MEETING WITH UNION Malcolm made a motion to authorize the Supervisor to speak with the union concerning this temporary increase to a starting salary of \$20/hour; seconded by Dave. Ayes 4 (Ferry, Debra Cook, Craig, MacKenzie) Noes 0. Motion carried.
- Steve noted that the Yates County Workforce Development program has reinstated funding for highway crews to hire and allow for CDL training. There are requirements to be met.
- 156 MOTION TO ADVERTISE & HIRE FOR TRAINING Malcolm made a motion to advertise and authorize the hiring of a temporary highway worker to learn the job before 1/1/2024; seconded by Dave. Ayes 4 (Ferry, Debra Cook, Craig, MacKenzie) Noes 0. Motion carried.

DANBOY RD.

- Recently the Town had agreed to begin the second step of discontinuing Danboy Rd. The property owner did not agree with the language and submitted his own paperwork. It was pointed out that the wording in this paperwork is incorrect.

- Supervisor Craig feels that the Town should grant a total discontinuance of Danboy Rd.as requested by the property owner. Deb Cook and Dave Ferry both agree. Both Town Attorney Ed Brockman and Malcolm MacKenzie disagree with a total discontinuance.
- There was a lot of discussion. Supervisor Craig had visited the property and while there, the NYSDEC officer was present. Both Richard and the DEC officer explained to the property owner that warnings are not effective in stopping the trespassing. He needs to get serious and bring charges. Richard does not know why there is such disagreement about the discontinuance of Danboy Rd. It serves no useful purpose for the Town. Dave and Deb Cook agree that this argument has been going on for several years.
- Ed maintains that there is no legal precedence for this action. Malcolm agrees but is willing to see a written precedence that supports Richard's position.
- Steve Faulkner asked for clarification between a discontinuance and a qualified abandonment. Ed explained the differences.
- Steve will call the property owner to get the wording corrected so the process can move forward properly.
- 156 MOTION TO DISCONTINUE DANBOY RD Deb Cook made a motion to grant the discontinuance of Danboy Rd. There was further discussion. No action taken.

BID PROCESS

- Currently the Town has advertised for proposals for engineering services and disaster recovery consultant concerning FEMA projects which include culverts on Martin Rd and Lower Rd.
- The deadline for bids being submitted are due is Thursday, December 28, 2023 at noon. Board members will review and award the bids at the December 29, 2023 year-end meeting.

- SOLAR LAW:
- Malcolm noted on page 3, #5F. fees are mentioned that pertain to engineering cost, site plan cost, environmental and legal services. There should be language added to address these costs before the project begins.
- On page 3 #6A it was noted that all roof mounted solar systems are covered by NYS Building Code.
- On page 5 #8 B12, Malcolm thinks grazing should be added to anticipated dual use.
- On page 5 #8 B13, Malcolm asked who would oversee the Decommissioning plan. An engineer should be consulted.
- Malcolm does not see a bond requirement for Tier 4 systems.
- Town Attorney Ed Brockman will review the proposed solar law and submit any suggestions.

LEGISLATIVE REPORT

- YC Legislator Doug Paddock reported this month.
- The 2024 Yates County Budget has been adopted. The tax rate was reduced from 2023.
- The YC Legislature has adopted a resolution to share the Code Enforcement Officer with Schuyler County.
- The Animal Control Agreements between the county and the municipalities have been signed.
- The Legislature has adopted a local law to allow for the hiring of a Deputy County Clerk from outside Yates County.
- The broadband expansion is progressing but getting permission from the utility companies has been difficult.
- YC Legislator Tim Cutler has officially resigned. There are recommendations from the Democratic and Republican parties of the municipalities to be considered.

PRIVILEGE OF THE FLOOR

- Sande Johnson asked about the newly elected Highway Superintendent, Ben Huff. She also asked about the status of the FEMA project. It was explained that the newly elected Hwy Superintendent has not been in contact with the highway department since the election. Malcolm had spoken with Ben and encouraged him to attend the board meeting and to reach out to the highway department. Malcolm also offered to go with him to the highway garage to make introductions. As far as the FEMA project goes, the FEMA consultant and several others will be meeting with FEMA representatives on Wed. Dec. 13. Supervisor Craig believes that it was the right decision to hire a FEMA consultant.
- Mark Schlegel had previously spoken with Hwy Superintendent Steve Faulkner about the possibility of purchasing the building that he currently leases from the Town. His proposal included a trade of construction services for the building.
- Malcolm is concerned about the logistics of property transfer, right of ways, surveys and the expense of all that. Ed Brockman says a survey would not be necessary.
- There was some discussion as to what would be needed. As a result of this discussion, it was decided to speak with the Assessor to determine a fair value of the building and a prorated value of a small parcel. Once the board members have this information, the proposal can be considered.
